Nick Boles, Minister for Planning, Visits Woodford

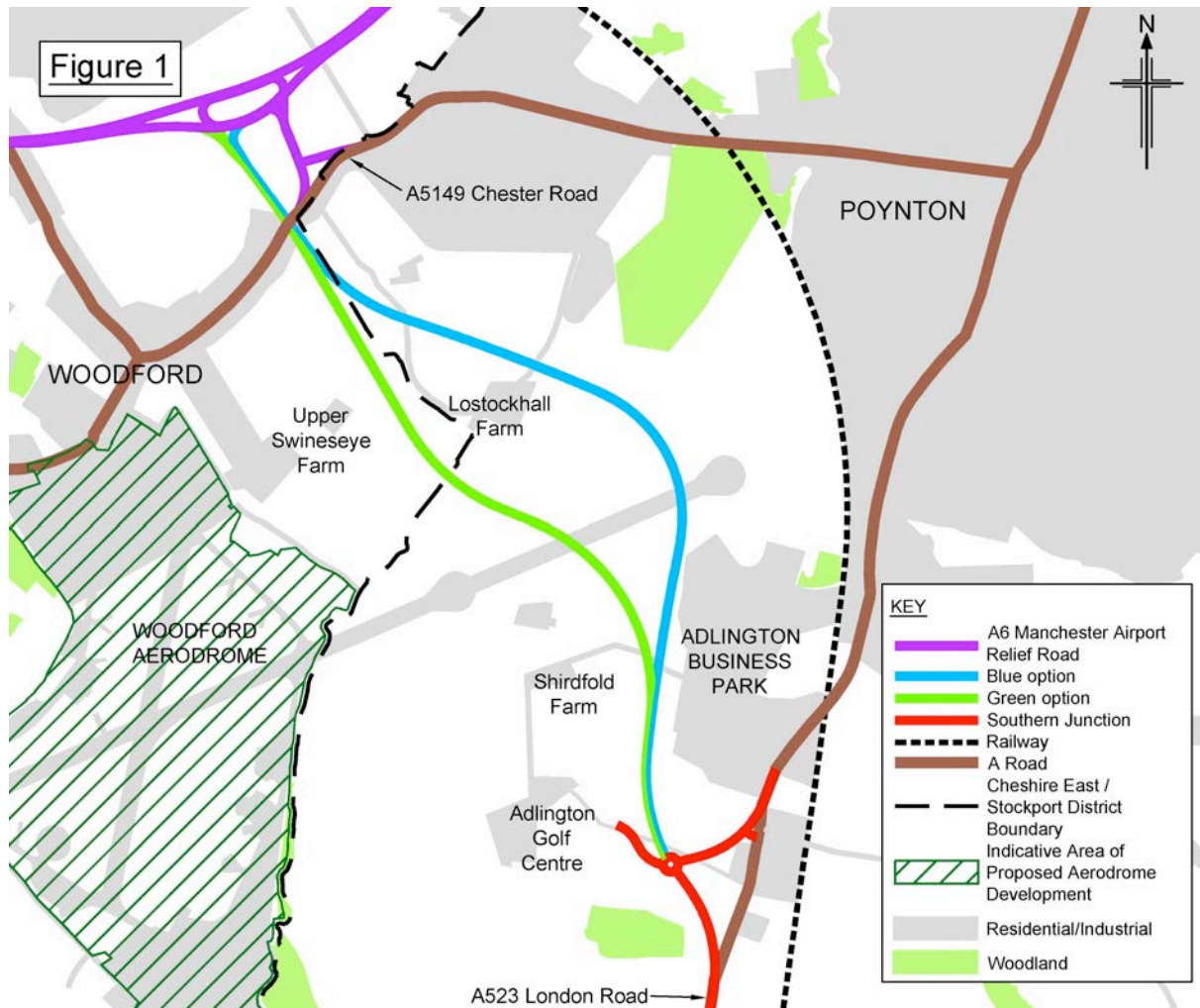

He gave us an insight into the Government's policy on greenbelt and local area involvement in planning decisions, as well as useful suggestions relating to our situation in Woodford.

Consultation on Poynton Relief Road

Cheshire East Council commenced the public consultation on the Poynton Relief Road on Monday, 2nd June 2014 until Monday, 28th July 2014. The proposed road should link in with SEMMMS at the Poynton – Woodford border and link to the A523 London Road at the Adlington Industrial Estate.

Woodford LocalLink Flexible Bus Service

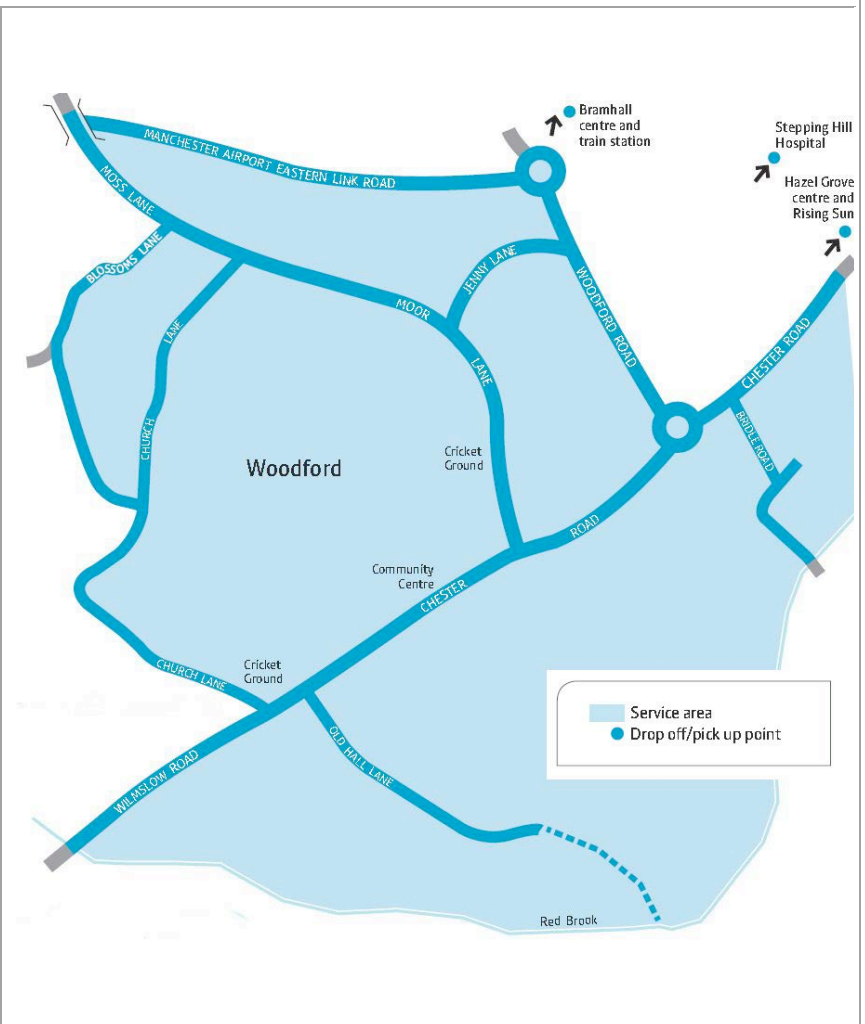
Transport for Greater Manchester, TFGM, have introduced a 'LocalLink' bus service for the Woodford area following the ending of the 390 service. LocalLink provides services in areas where other services are limited. Anyone wishing to travel to or from the local area and the designated destinations can use the service and there are no age or disability restrictions. LocalLink is a shared service so you may be travelling with other passengers.

The Woodford LocalLink bus will pick up / drop off anywhere within Woodford for journeys to and from Bramhall

centre, Bramhall train station, Hazel Grove centre, Hazel Grove Rising Sun and Stepping Hill Hospital.

To book your LocalLink journey:

- Call 0161 343 6449 and ask for LocalLink
- The booking centre is open 24/7
- Please call at an hour before you wish to travel
- You can book your journey up to one week in advance
- Please state if you want a return journey
- Inform the Centre if you will use a wheelchair or child buggy so an appropriate vehicle can be provided

Plans for Development at Handforth Submitted to Secretary of State

The Cheshire East Local Plan Strategy, which includes a proposal for a North Cheshire Growth Village comprising around 2,000 new homes in Green Belt adjacent to Woodford, was submitted to the Secretary of State for Communities and Local Government on 20th May 2014 in preparation for independent examination. The submission includes the comments received during the representation period.

The Cheshire East Local Plan Strategy will now be subject to an independent examination to be conducted by the Planning Inspectorate. Inspector Stephen Pratt BA (Hons) MRTPI has been appointed to conduct the examination to determine whether the Local Plan Strategy is sound. The process will include hearing sessions where those invited to attend will have the opportunity to respond to matters raised by the Inspector.
